These Terms and Conditions of Use state the terms and conditions under which you may access or browse the Greatamericancoincompany.com website and govern your use of the website. By browsing, using and placing an order for products through the Greatamericancoincompany.com website (the "Website"), you agree to the terms and conditions set forth below (the "Terms and Conditions"). These Terms and Conditions is a legally binding agreement made by and between Great American Coin Group, LLC dba Great American Coin Company ("Great Am Coin," "our," "we" or "us"), and you, personally and, if applicable, on behalf of the entity for whom you are using the Website ("you" or "your"). The Terms and Conditions govern your use of the Website and the products and services we offer on the Website, including making purchases from Great Am Coin, making sales to Great Am Coin, making payment to or receiving payment from Great Am Coin, and placing orders with Great Am Coin.

5. Cancellation Policy
